- 1) Agree prior to participating, that I will inspect the wheelchair and access point to be used. If I consider any part of either unsafe, then I will report the problem to the proper authority, and I will refuse to use either.
- 2) Acknowledge and fully understand that the person(s) using the wheelchairs and access points will be engaging in activities that involve inherent risks of personal injury, including permanent disability, or death, and severe social and economical loss which might result not only from their own actions or negligence, but the actions and negligence of others, or the conditions of the premises or equipment used. Further, there may be risks unknown or unforeseen by us at this time.
- 3) Assume all the foregoing risks and accept personal responsibility for the damages of equipment and self, following such injury, permanent disability or death.
- 4) Release, waive, discharge and covenant not to sue the Town of Oak Island, the Oak Island Parks and Recreation Department, wheelchair custodian, administration, directors, employees, sponsors, advertisers, all of which are referred to here and after as "releases" from any and all liability to each including death or damage to property, caused, or alleged to be caused in whole or in part by the negligence of the release or otherwise.
- 5) **I have been informed by staff that I am allowed to check out the wheelchair for 2 days and it is due back by 9am on the 2<sup>nd</sup> morning. For example, if the chair is checked out on Monday it is due back by 9am on Wednesday. If a chair is checked out on Saturday, it is due back by Monday morning at 9am. *The chair must remain on Oak Island.***

The undersigned has read the above waiver and release, understands they have given up substantial rights by signing, and signed voluntarily.

## **Beach Wheelchair Check List**

\_\_\_\_\_ Beach Wheelchairs are in high demand during the warmer months. Chairs may be checked out for a two day period. Please promptly return the chair to the Oak Island Recreation Center located at 3003 E. Oak Island Dr. by 9am on the second day of your rental. Any questions, please call the Recreation Center at 910-278-5518.

\_\_\_\_\_ Chairs are not collapsible. Renters are responsible for transporting the chair to and from the center. You will need a vehicle large enough to transport the chair such as a pickup truck. The Recreation Department does not have vehicles to transport chairs.

\_\_\_\_\_ **Tires are low pressure and are designed to be soft and flexible. DO NOT USE COMPRESSED AIR TO INFLATE THE TIRES. If air is needed, use a bicycle pump only and inflate to 2.5 psi!**

\_\_\_\_\_ Please help us to protect our chairs from the damage of sand and salt water by rinsing the chair before you bring it back to the Recreation Center.
