Vendors may start selling their merchandise at 1:00 p.m. Vendors will be required to discontinue sales and begin cleanup at 4pm. Spaces are approximately 10 x 10 and will be assigned by staff. Food vendors must meet current health regulations and all other vendors may only sell/distribute pre-approved merchandise that is appropriate for all audiences.

All vendors are responsible for supplying their own tents, tables, chairs and for setup and cleanup of vending area.
